



Eyal Run Bylaws

1. <u>Participation Terms:</u>

1.1. As a result of the court ruling, each participant at a distance of 10 km or more must present and sign a participant health declaration stating that he/ her complies with the Sports Law requirements and removes the responsibility from the race organizers. Please submit the form when collecting the participant kit. A participant who does not submit a signed health statement will not be able to receive the participant kit and will not be able to participate in the race.

1.2. Participation in the Eyal Run is forbidden in the following cases:

- 1.2.1. Body temperature exceeding 38 degrees celsius on the day of the race.
- 1.2.2. If I experience cough and / or respiratory symptoms (except for a cough caused by chronic asthma or allergy)
- 1.2.3. If I have been in contact with a verified corona patient in the three weeks prior to the race date.
- 1.2.4. Lack of physical / mental competence
- 1.3. It is advised for each participant to become familiarized with the tracks before the competition.
- 1.4. Each runner must ensure that he is insured with appropriate insurance that includes appropriate coverage for his needs, in the event of injury or damage.
- 1.5. Participation in the race at all stages will be at the sole responsibility of the participants in the race.
- 1.6. I know that this is a competition in high intensity, which involves physical and mental efforts and that the tracks pass through roads, open areas and fields that may be with water puddles, mud in hot / rainy / humid weather. A participant who decides to run in these conditions, is aware of the conditions and removes the organizers responsibility in the event of a skid or fall or injury caused by these conditions.
- 1.7. I am aware that the management of the race, the municipality, the council, Shvoong or any other body related to the race will not be held liable for any damages that may be caused to me including body injuries caused prior, during or after the race, nor for any loss of property or equipment. Therefore, I waive any right to any tort claim against the above entities.
- 1.8. The participant absolved the race management or entities on her behalf absolutely, completely and irrevocably from responsibility for any damage, loss, or expense of any kind whatsoever, including legal expenses directly or indirectly





- related to the race. In addition, the participant hereby completely, definitively and irrevocably, waives any claim and / or demand against the race organizers and / or anyone on their behalf in connection with the race participation.
- 1.9. I know that in order to be included in the categories of the competitive tracks, participants must pass through all the time measurement tapestries along the route. For the full tracks description <u>click here</u>.
- 1.10. The Eyal Run management is entitled to make changes in the race tracks and schedules in accordance with police instructions and due to unforeseen and unknown factors that could interfere with the proper execution of the race or endanger participants and organizers.
- 1.11. Order must be maintained throughout the race course, including respecting people on the roadside and / or race participants, private property, public property and so on.
- 1.12. It is required to follow the direction signs placed by the race organizers and / or anyone on their behalf and follow instructions of the race organizers and their representatives throughout the race.
- 1.13. In the event that a participant violates the race bylaws and / or if suspicions of misuse of given eligibility, the organizers may ban participation in the race and the participant will have no claim against the race organizers and / or against anyone on the organizers behalf for ceasing the participation in the race under these circumstances.
- 1.14. The race management may change the terms of participation and / or prizes at any time, subject to its sole discretion and without prior notice.
- 1.15. Parental consent of a participant under the age of 18 is required. Participation in the 15 km track is from the age of 15 and above. Minors required to present a removal of responsibility form and a health declaration signed by the parents.
- 1.16. I agree that the race management and Shvoong will be allowed to use my photographs during the race, before the race and at the end of the race for advertising and public relations purposes, free of charge as well as publishing my results on the race website, 4sport website and Shvoong website.
- 1.17. I know that there is no commitment of race organizers to availability of specific sizes of race shirts on demand at the pickup of participation kits. The shirts are ordered many months in advance and are distributed according to inventory availability on site. We recommend collecting the participant kit as early as possible.





- 1.18. I know that the cut-off will be in accordance with the schedule posted on the race site.
- 1.19. Dogs or other animals are not allowed to attend the event (with / without a leash).

2. <u>Cancellation policy:</u>

- 2.1. A participant who is registered for the Eyal Race will be entitled to cancel his participation under the following conditions:
 - 2.1.1. Cancellation of registration must be carried out up to 7 working days before the event by filling out the <u>change and / or cancellation form</u>.
 - 2.1.2. Remote Sales Transaction Cancellation Law- Cancellation of registration must be carried out up to 14 working days from the date of registration for the race and on condition that the cancellation notice was delivered no later than 7 working days before the race date. For any such cancellation, a cancellation fee of 5% of the registration fee or 100 NIS, whichever is lower, will apply.
 - 2.1.3. In the event of cancellation after more than 14 working days from the date of registration, the cancellation fee will be as follows:
 - 2.1.3.1. As of September 14th, a cancellation fee of 30% will apply.
 - 2.1.3.2. As of October 14th, a cancellation fee of 50% will apply.
 - 2.1.3.3. As of November 4th, it will not be possible to cancel and the registration fee will be fully charged.
 - 2.1.4. Cancellation of the race will be done by filling out the <u>change and / or cancellation form</u>.

2.2. Cancellation by Eyal Run organizers due to unforeseen circumstances:

- 2.2.1. The preparation for the Eyal Run requires significant work and preparedness many months before the event. The purpose of the Eyal Race is to hold an impressive and honorable commemoration event whereas the execution of the event depends on receiving all the necessary permits without any unexpected restrictions that are beyond our control.
- 2.2.2. However, in light of the investment required to organize and produce the race ahead of time and the fact that there may be unforeseen restrictions influencing the execution of the event, the participation in

the Eyal Run is conditioned in the consent that upon such event of cancellation due to unforeseen circumstances such as the instructions of the Israeli Police and / or other security authorities and / or the Ministry of Health and / or due to a hostile terrorist activity and / or weather damage and / or health restrictions and guidelines such as COVID-19 and / or poor infrastructure, participants will be refunded 50% of the registration fee. The refund is subject to a written request up to 14 working days following the date of the Eyal Run cancellation by the organizers, by filling out the change and / or cancellation form.

- 2.2.3. In the absence of a reimbursement request, the registration fee will entitle the participant to a future participation in the Eyal Run in a similar track at no additional cost.
- 2.2.4. By registering to the Eyal Run, you approve and acknowledge this condition, accept it and agree to it.
- 2.2.5. If the registration payment was made by credit card and the credit card company or another organization through which Shvoong contracted to make the payment has charged Shvoong for the credit card payment in the canceled transaction, Shvoong will be entitled to charge the participant for the fee that was charged from her.
- 2.3. In the event of non-attendance for any reason after the cancellation deadline, the registration fee will not be refunded and registration will not be possible for another participant. A participant who did not cancel the registration will be entitled to receive the running kit for up to 14 days after the Eyal Run subject to an advance written coordination up one day before the competition.

3. Changes procedure:

3.1. Registration changes can be made up to 7 working days prior to the date of the race. In order to transfer a registration to another runner, you must apply using the change / cancel registration form with information about the registered participant and the alternate runner (full name, year of birth, gender, sport association, race track, order number, chest number if already assigned). The participant details will be updated as part of the race results. There's no commitment that the details will be updated on the chest number.

4. Registration procedure:





- 4.1. Use of coupon code Coupon code is given to a group over 20 participants and can be received in coordination between the event managers and the team manager / coach. You cannot receive a discount in retrospect and / or a credit to a person who did not use the coupon code they had.
- 4.2. Cost of telephone registration is 20 NIS in addition to the registration price.
- 4.3. Participation is subject to registration up to three days before the race.

5. Awards and trophies:

- 5.1. The awards are designated for residents of the State of Israel who have been living in Israel in the last year and a half minimum.
- 5.2. There are no double awards.
- 5.3. Trophies and prizes will be awarded to all categories.
- 5.4. The year of birth is the determinant of age groups.
- 5.5. A participant who is entitled to an award / trophy and will not be present at the awards ceremony will not be able to claim the award in retrospect.
- 5.6. Minimum of 10 runners per category. If there is no minimum of 10 runners, the category will be canceled and added to the age category below it (except if this is the first age group and then it will be consolidated with the category above it).
- 6. I know that by registering and participating in the race I agree to the race bylaws.
